## TRAILS & FACILITIES DEVELOPMENT





### **Paved Recreation Trail**

The 5 km paved loop at Mt. Telemark Village opened to the public during the fall of 2022 and has been heavily accessed by trail users of all ages and abilities, from the youngest of athletes and elite skiers cross-training on roller skis to casual dogwalkers and individuals with limited mobility. This trail is serving a diverse demographic of users.

### **Observation Tower**

An observation tower was installed at the top of Mt. Telemark and opened to the public in the summer of 2023. A dedicated hiking path was also constructed to provide dedicated hiking access to the tower. The trail meanders up the old ski runs of Mt. Telemark and takes about 20 minutes to ascend at a leisurely pace. Thank you to the Quinn Family for making this project a reality!





### **Trek Trails Powered by OTM**

In 2022 approximately four miles of trails were completed as part of Phase 1 of the Trek Trails Powered by OTM. In 2023 construction of an additional six miles of trails began that will connect riders from the American Birkebeiner start area to Mt. Telemark. The first mountain bike trails on the front of Mt. Telemark should open fall 2023.

### **South End Trail Building**

ABSF built a storage facility at the southern end of the trail just off Wheeler Road in Hayward adjacent to the American Birkebeiner Trail. The new building stores grooming equipment and serves as a hub for race preparations. The ability to store a groomer indoors on the south end of the trail has greatly increased the frequency with which the south end of the trail can be groomed.



## **FINANCIALS**

A letter from the Treasurer.

It is a pleasure to present to members the unaudited annual financial report of the American Birkebeiner Ski Foundation (ABSF) for the fiscal year which ended June 30, 2023. Please note, the year-over-year comparison is to audit the previous year's financials.

#### **Overall Results**

For the fiscal year 2022-2023, Total Equity grew 30.2% to \$6.49m, Total Liabilities increased 20.1% to \$3.93m. Revenue exceeded Expenses resulting in Net Revenue (surplus) of \$1.81m from operations and Net Cash Flow of \$611k.

#### **Assets**

Total Assets grew 26.2% year-over-year to \$10.4m. Notable changes to Current and Fixed Assets include an increase in (cash) for the capital campaign, early Birkie week registrations for 2024 (cash) and Fixed Asset additions as stated below in Capital Expenditures.

#### Liabilities

Liabilities increased 20% due to an increase in deferred revenue (early registrations) for 2024 Birkie, Restricted Donations/Grant funds, and a decrease in LT Liabilities of 258k or 13%.

#### Revenues

Total revenues for the year increased 6.3% to \$5.97m. Noteworthy was a shift in donations from general Donation/Grant/Sponsorship towards the Restricted funds for the Capital Campaign. A large portion, 46.0%, of Total Revenue is in the form of Donations. The ABSF thanks members' generosity and continued support of the ABSF's mission.

#### **Expenses**

Expenses grew 14.8% to \$4.79m as the organization positions itself for the future. Increases in costs for Staff, Facilities and Trail represent the plan to grow and provide better experiences.

#### **Capital Expenditures**

New capital investments for improvements in Facilities of \$435k, Trail \$709k, Snowmaking \$50k and Telemark \$52k were completed, notably completion of the Wheeler Rd building, the paved trail, and improvements to the Derksen Family Great Hall.

A stronger balance sheet strengthens the financial health of the American Birkebeiner Ski Foundation and most importantly, prepares the organization for future growth in programs and infrastructure development. The Staff deserve our thanks for all their hard work this past year.

#### Notes on Financials Statements (Disclosures)

#### Our Mission

The American Birkebeiner Ski Foundation is a 501(c)(3) non-profit organization dedicated, as reflected in the Birkie Mission Statement, to hosting one of the world's best cross country ski events, the American Birkebeiner, maintaining one of the nation's premier recreation trails, and promoting healthy lifestyles for people of all ages. The American Birkebeiner is made up of several events in addition to the 50K and 55K Birkie marathon races and the 29K Korteloppet race (the second largest ski race in North America).

#### **Accounting Method**

The ABSF presents its financial statements on an accrual basis in accordance with accounting principles generally accepted in the United States of America (US GAAP). Certain items are maintained on a cash basis, which is not materially different from the accrual basis of accounting. The ABSF fiscal year spans July 1 through June 30.

#### **Basis of Preparation**

The financial statements include certain prior year summarized comparative financial information in total but not by net asset class. Such information does not include sufficient detail to constitute a presentation in conformity with US GAAP. Accordingly, such information should be read in conjunction with ABSF's financial statements for the year ended June 30, 2023, from which the summarized information was derived. All financials within are unaudited results.

#### Depreciation for Buildings, Furniture, and Equipment

Land, buildings, furniture, and equipment owned by the ABSF are stated at cost at the date of acquisition. Useful lives range from 39 years for buildings, 7 years for furniture, 5-7 years for heavy equipment and 5 years for technological equipment. Depreciation is calculated on the straight-line basis over the assets' estimated useful lives, except for land. ABSF reviews long-lived assets for impairment whenever events or changes in circumstances indicate that the carrying amount of an asset may not be recoverable. An impairment change is recognized when the fair value of the asset or group of assets is less than the carrying value. There was no impairment recognized for the year ended June 30, 2023.


